**Fresh Applications are invited for vacant seats in MBA (Executive) programme, DTU for 2022-2024 Batch.**

1. Interested candidates are required to go through the brochure of MBA (Executive) admission for 2022-2024 batch.
2. **Eligible candidates are required to register as per instructions given on portal and in the brochure.**

**Eligibility Criteria (As per Admission Brochure)**

Graduation or its equivalent with minimum 50% marks or equivalent CGPA (10% relaxation in marks will be given to SC/ST/PwD).

**Work Experience:**

- (i) Minimum 3 years work experience after four years degree (B.E., B.Tech. B.Arch. etc.)  
OR
  - (ii) Minimum 4 years work experience after three years degree (B.A, B.Sc., B.Com, BCA, etc.).
3. The eligible candidates are required to bring following original documents for physical verification.
    - i) Class X Certificate as a proof of Date of Birth.
    - ii) Degree and all Mark Sheets of qualifying examinations.
    - iii) Category Certificate (SC/ST/OBC/EWS).
    - iv) Original documents in respect of experience mentioned in application form.**
    - v) No Objection Certificate from the employer with current designation of the candidate and permission to attend the classes for the whole day on Saturday and Sunday during all the four semesters in the period 2022-24.
    - vi) Demand Draft of Full Fees.
  4. The eligible candidates will appear for Personal Interview on same day (August 27, 2022) and result will be declared after the interviews.
  5. Successful candidates are required to deposit the fee through bank demand draft of Rs. 2, 41,700/- (Two Lakh Forty One Thousand Seven Hundred only) in the favour of **The Registrar, DTU payable at Delhi.**

**Note:** The fee deposited in the special SPOT round is non –refundable. At any stage of the program, if it is found that the candidate does not fulfil the eligibility criteria, his/her admission shall be cancelled and the fee shall not be refunded.
