SPOT round for Admission to B. Tech. courses in DTU through DASA for the Academic Session 2022-2023 (Offline Mode)

Spot Round of DASA admissions will be held on 15th November 2022 (offline Mode). All applicants who have not allotted seats in the previous rounds and those who were not eligible for allotment in the previous rounds and later on became eligible, may also register for the spot round. Further, applicants who have declined their allotments or withdrawn/cancelled their applications are eligible to re-register for the spot round after paying a re-registration fee of USA\$ 300 (US Dollars Three hundred only) and may report for the admissions as per the following schedule:

Reporting Date & Time: 15.11.2022 (10:00 A.M.)

Venue: Office of International Affairs (OIA), DTU (in person)

Spot round of counselling will be in OFFLINE MODE ONLY. The reporting time for attendance will be closed by 11:00AM and thereafter no candidate will be entertained/allowed to mark his/her attendance. The allotment of seats will be done according to the Merit Serial Number of the candidates who have marked their attendance. Candidates are required to report physically to the spot round venue at the above-mentioned date and time.

No refund of fee on withdrawal: There is no provision of any refund/withdrawal of money for the admitted students in the DASA spot round.

Candidates are required to bring the following documents for admission in original along with ONE set of self-attested photo-copies of the original documents (MANDATORY), two recent passport size photographs, printout of the registration form duly signed by the candidate for the purpose of verification at the time of admission.

1. Original transcripts/ certificates need to be produced during the verification.
2. Copy of proof for date of birth (Secondary Education Board/University Certificate [Class X or equivalent] or any certificate issued by the Government authorities).
3. Mark Sheets of 10th, 11th, and 12th, (or) equivalent examination.
4. Copy of certificate from School authorities (in the format given in Appendix – II of DASA 2022 brochure on letter head of the school) as proof of completion of 11th and 12th Standard or equivalent.
5. Proof of Fee payment.
6. Anti-ragging –Affidavits (Annexure I & II).
7. Self-declaration and undertaking forms (Annexure III).
8. Medical Fitness (Annexure - IV).
9. Certificate in Appendix III of DASA 2022 brochure in case of CIWG Candidates.
 - a. Passport of the Parents working in the Gulf in case of CIWG Candidates.
 - b. Parents Visa in case of CIWG Candidates.
 - c. Parents work permit (if any) in case of CIWG Candidates.
10. Copy of candidate's Passport: (Nationals of Nepal and Bhutan who do not have a passport, copy of **Authenticated Citizenship** Card has to be submitted*).
11. Candidates must share their JEE Mains Examination User ID and Password for verification.
12. If any supporting documents are in languages other than English or Hindi, an authenticated translated copy of the documents in English or Hindi must also be provided.
13. Incomplete/ illegible applications and documentary evidence in any respect would be summarily rejected without any communication to the candidates.
