List of candidates called for First round of counselling (Subject to the conditions mentioned below related to document verification and eligibility) for MBA (Business Analytics) Admission 2023.

Instructions to Candidates for First Round of Counselling

1. Please find below the list of candidates called for the first round of counselling.
2. The candidates have to report at **10:00 AM** on **23rd June 2023** at **Auditorium, East Delhi Campus, Delhi Technological University, Vivek Vihar Phase II, Delhi 110095**. Candidates will not be allowed to mark their attendance one hour after the reporting time and late-comers will not be eligible for the first round of counselling.
3. The allotment of seats will be done according to the merit of the candidates who mark their attendance and as per the seat matrix given in the Admission Brochure.
4. The mode of Admission fees payment is **Demand Draft (DD)** issued in favour of **'Registrar, DTU Admission, East Delhi Campus'**, Payable at Delhi. The admission fees in any other payment mode will not be accepted. The required fees as per fee structure (Rs. 2,29,000/-) is to be paid on the day of counselling i.e., on 23rd June 2023.
5. Demand Draft has to be submitted at the time of counselling, to avail of seat. If not submitted, he/she will forfeit the seat and will not be considered for further rounds of admission except for spot round(s).
6. Please note that any requests for extension of fees payment **will NOT** be entertained.
7. All candidates are requested to bring following original documents for verification on the day of counselling:
 - i) Two Photographs
 - ii) Medical fitness certificate
 - iii) Graduation marks sheets and degree
 - iv) 10th & 12th marksheets and certificate.
 - v) CAT2022/MAT2022/MAT2023 scorecard
 - vi) Experience certificate, if applicable.
 - vii) SC/ST/OBC /EWS certificate, if applicable.

Note: The formats of some of these certificates have been provided in the Admission Brochure. In case of OBC-NCL and EWS categories, the certificates should be issued after March 31, 2023. The candidate's names on the reserved category certificates and Class XII marksheet should be exactly the same, otherwise an affidavit to this end will have to be produced.

8. In case a candidate is appearing in final semester/year, he/she would be considered for provisional admission subject to submission of final year result/mark sheet by 31.08.2023, 5PM, failing to which, they will forfeit their seats and their admission will be cancelled.

Note:

- 1. Calling of the candidates for counselling shall not be considered as entitlement for admission. Greater number of candidates than seats available have been called to ensure that seats do not remain vacant. In case, a candidate is absent, the seat will be offered to the next candidate in the merit list.**
- Candidates who have been invited to participate in the first round of counselling, but fail to appear, will not be allowed to participate in the subsequent Counselling rounds. However, they may participate in the **spot round** (if any).
- Candidates who cannot come physically can authorize their parent/relative/guardian/friends as their representative to participate in the counselling round on their behalf and complete admission formalities. No other relaxation will be given in the procedure of admission. Respective representatives will have to carry a valid ID proof and letter of undertaking from the candidate along with original & photocopy of required documents. Only the student or his/her one representative will be allowed inside the counselling venue to maintain social distancing norms.
- Limited parking facility will be available at the venue. Candidates are advised to use public transport to reach the venue. The nearest stations of the Delhi Metro are Mansarovar Park on the Red Line and Karkardooma on the Blue/Pink Line.
