- b) Demand draft for Rs. 1,50,000/- made in the favour of "Registrar, Delhi Technological University" payable at New Delhi.
- c) A duly signed printout of the filled application form (same as submitted online) along with two good quality photographs (same as uploaded on online application form) affixed in the appropriate place on the form.
- d) All the mark sheets and certificate (Original) of qualifying examination (Diploma).
- e) Candidates seeking admission under Economically Weaker Section (EWS) need to provide EWS certificate as per Annexure-IV (available at www.dtu.ac.in)
- f) SC/ST/OBC Certificate(s) whichever applicable, on the basis of which reservation is claimed. OBC-NCL candidates must produce necessary financial document to support their category as per Annexure-II.
- g) Attested copy of Person with disability certificate (if applicable) as per Annexure-III.
- h) Appointment letter from the present employer (Original).
- i) A 'No objection Certificate' by present employer as per Annexure-I. (Original)
- j) Employer's company profile.
