Note:-

- a) All General category candidates must report at 10:00 am on 12-08-2023.
- b) Candidates must report on time; otherwise, they will not be considered for seat allotment.
- d) The candidates who failed to produce /update a valid category or subcategory certificates at the time of document verification and have their name in the merit list, such candidates have to report as General Category candidates.

**1. Guidelines for First Round of Counselling**

- a) The list of all selected candidates for the first round of counselling is published on the DTU website www.dtu.ac.in
  - b) The Candidates have to report as per schedule and must mark their attendance immediately after reporting.
  - c) After marking attendance, The Reporting Candidates or their representatives will collect their file from the desk and admission slip and declaration form and place the demand draft in the file.
  - d) Reported Candidates will be called according to their rank for seat allotment. The allotment of the University will be done based on the merit list and availability of seats in each category.
2. Candidates who cannot come physically can authorize their parent/relative/guardian/friends as their representative to participate in the counselling round on their behalf and complete admission formalities. No other relaxation will be given in the procedure of admission. Respective representatives will have to carry a valid ID proof and letter of undertaking from the candidate along with original & photocopy of required documents.

**3. PAYMENT OF SEAT ACCEPTANCE FEE**

- a) The demand draft of amount Rs. 2,73,700/- should be submitted in favour of **REGISTRAR DTU Admission East Campus**
- b) Failing to attend the counselling or to submit the admission fee, the allotted seat will stand automatically cancelled and the candidate will not be considered for present or subsequent rounds of seat allotment (except/ for spot round).
- c) The demand draft should be of amount Rs. 2,73,700/- in favour of **REGISTRAR DTU Admission East Campus**
