Prior to joining Delhi Technological University during July, 2012, served in the Centre Government for more than twenty five years. He joined Indian Statistical Service (ISS) in the year 1986 as Group 'A' direct recruit officer through UPSC based on an all India competition. After rigorous initial cadre training - which included training at several prestigious institutes/organizations spread across the country, compulsory stay at a village and trekking to remote hills to get exposure to life at grassroots - he was posted as Research Officer in the Market Research Division of the Department of Tourism (DoT), Government of India, New Delhi in the year 1988. His contribution during the service period at DoT primarily included organization of progressive computerization of the department, analysis of tourist statistics, organizing tourism potential surveys and, monitoring and evaluation of project studies.

He later joined National Informatics Centre (NIC) in the year 1993 through direct recruitment mode. He has served at different levels in NIC (ranging from Senior Systems Analyst to Senior Technical Director) and worked, over the years, for the strengthening of agricultural informatics in the country by building ICT enabled synergetic relationships with various organizations in Government and Non Government domains. He has travelled across the nation to interact with stakeholders at various levels and contributed in the evolution of several information systems in the agriculture and allied sector. In particular, he has been the NIC National Co-ordinator for implementing the ambitious e-governance project "Agricultural Marketing Information Network System (AGMARKNET)" in 3000+ markets spread across the nation with the support of the Directorate of Marketing and Inspection, Ministry of Agriculture and Farmers' Welfare and various State Marketing Boards/Directorates. The national project has won several accolades at national and international levels. His contribution to strengthen systems

has been in terms of planning, strategy formulation, strategic gap analysis for improving systems, establishment of ICT infrastructure, system design, development and implementation, monitoring and control of projects, organizing nation-wide capacity building and sensitization programmes, system documentation, organizing national/state level stakeholders' workshops, participating in deliberations at national and international forums for improving systems from beneficiaries' perspective, etc.

He has also served in consulting roles for the UN bodies, viz. World Tourism Organization and, Food and Agricultural Organization.

He has publications in both International Journals and Conference Proceedings and delivered invited lectures/addresses in several Government and academic Institutes.
