- 1. The assignment is purely as Guest Faculty in the mode of either on hourly remuneration basis, "as and when required nature basis" as decided by the selection committee/respective Head of Departments.
- 2. No experience certificate shall be issued for taking up the assignment.
- 3. For B. Tech/M. Tech/MBA classes payment of Rs. 1500 & Rs. 2000 per hour and Rs. 750 & Rs. 1000 per practical period respectively depending upon the experience of Assistant Professor/Associate Professor/Professor. Payment shall be made for only the classes actually held and not on the basis of scheduled classes. Thus the payment for each lecture and practical shall be Rs. 1500 and Rs. 2000 respectively per period. However, the maximum amount payable shall not exceed Rs. 33,250/- and Rs. 46,550/- per month for those assigned on "per hour basis".
- 4. Rates for conducting term and practical examinations/term end examinations in sessional shall be as per the University norms.
- 5. No extra payment shall be admissible for evaluation of the answer books of mid term test, it shall be considered part of the mid term test.
- 6. Applications should reach to the Registrar by 25.07.2016 in an envelope superscribed "Guest Faculty for the department of......".
- 7. Submission of application does not entitle to being engaged as a guest faculty.
