## TERMS AND CONDITIONS FOR ENGAGEMENT OF SPORTS COACHES ON CONTRACT BASIS:

Name of Game: Basketball, Badminton, Cricket, Football, Volleyball, Gym Trainer

1. He/She has to be a graduate with NIS diploma in the discipline applied for or He/She should have participated in Olympic / Asian Games / World Championship with Certificate Course in Coaching.
2. He / She has done the work of coach i.e. talent search and imparting training to the sports persons.
3. He / She will be paid remuneration of Rs. 23220/- per month (Excluding 2nd Saturday, Sunday, National and Gazetted holidays).
4. The period of appointment will be initially for four months w.e.f. the date of joining duty.
5. If he / she is required to proceed on tour on official duty he /she will be entitled to TA/DA as admissible under the normal rules.
6. The appointment can be terminated at one month notice from either side.
7. He / She will not be entitled to the facilities like reimbursement of Medical expenses and Leave Travel Concession.

The appointment does not bestow any right upon the coach for regular appointment in the University.

Attested copies of the testimonials are to be enclosed with the application.
