CORRIGENDUM

RECRUITMENT TO FACULTY POSITIONS

In continuation of advertisement No. F.DTU/Recruitment/03-2020/F-885/1475 Dated: 24.11.2020 of DTU regarding filling up of the posts of Professor in the disciplines of Management and Economics by direct mode of recruitment at University school of Management and Entrepreneurship (USME), the following may be read as part of the detailed advertisement: -

For the disciplines of Economics and for the discipline of Management clause 'B' under the heading 'Essential Qualifications and experience' of Recruitment Rules

1. *A minimum of 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed) at the Master's level shall be the essential qualification for direct recruitment of teachers and other equivalent cadres at any level.*

A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Non-creamy Layer)/Differently abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.

2. *A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to September 19, 1991.*

All other conditions (Pay Scale, Essential Qualifications, Relevant Branch & Relaxations) as mentioned in Recruitment Rules in advertisement for the disciplines of Economics and Management shall remain same.

Only those candidates who, in earlier advertisement, could not apply due to the aforesaid relaxation, may apply online up to 07.01.2021 by 5pm and also submit the print out of online filled Application Form, Annexures I, II, and III (Visit University Website for details) along with the desired/relevant documents and prescribed fees to the Recruitment Branch, Delhi Technological University, Shahbad Daulatpur, Bawana Road, Delhi-110042 latest by 07.01.2021 by 5pm.
