**ORDER**

In pursuance of All India Council for Technical Education notification dated 08<sup>th</sup> November, 2012 and its clarification dated 04.01.2016, policy for counting of past service for the purpose of Career Advancement Scheme (CAS) for faculty under purview of Department of Training & Technical Education, Govt. of NCT of Delhi, in addition to guidelines issued by AICTE from time to time is framed as under :-

- Each individual case shall be evaluated separately for the grant of higher scale under CAS and the benefit shall be given from the date, the teacher meet minimum eligibility conditions as fixed by the AICTE, after joining the Services in Govt. of NCT of Delhi.
  - Counting of past service rendered by a faculty can be considered only for grant of Senior Scale and not for selection grade, owing to the fact that such faculty has to render at least 05 years of regular service in Sr. Scale in the Institute (of Govt. of NCT of Delhi) in order to be eligible for grant of Selection Grade.
  - Benefit of counting of past service may be given up to maximum of 05 years at the entry level only.

Further, it is directed that all case of counting of past services, where benefit of CAS has already been given, may be reviewed as per above policy/norms.
