Subject: Points for FDPs conducted by IITs/NITs/IITs/ IIITD-regarding.

Sir/Madam,

1. AICTE has published a Gazette Notification No.34-36/RIFD/FDP through MOOCs/2017-18 dated 3rd August, 2018 on the Regulations "All India Council for Technical Education Regulations, 2018 (Career Advancement Scheme) (Degree/Diploma). As per this Notification, all faculty members who successfully complete advanced courses offered by NPTEL (through MOOCs mode) and obtain the certificate, shall also be considered for faculty promotions under CAS.
2. In line with the above mentioned notification, the credits applicable to the faculty attending such online FDPs conducted by IITs/NITs/IITs (including Certificate Program in CS Education offered by IIITD with support of ACM) will be as per the table reproduced below, from the ibid Gazette Notification: -

S. No.	No. of weeks of NPTEL Courses	No. of Hrs. of engagement per week	Total No. of Hrs. of engagement	Equivalence of NPTEL courses with regular FDP
1.	4	3	12	½ FDP of one week
2.	8	3	24	Full FDP of one week
3.	12	2	36	1 ½ FDP

3. Faculty from AICTE approved Degree/Diploma institutions who wish to participate in such online courses conducted by IITs/NITs/IITs (including Certificate Program in CS Education offered by IIITD with the support of ACM) may register directly after obtaining due approvals from the heads of their respective institutions and will be eligible to claim benefits as stated in para-2 above, for purposes of CAS/Promotions.

You are requested to disseminate the information to all your faculty members.







