**Sub: - Blacklisting of M/s Sunil Yadav - reg.**

Whereas, the Contract for running Central Canteen in DTU was awarded to M/s Sunil Yadav vide office letter bearing No. DTU/ Gen. Admn./118/2015-16/721-P/187 dated 17.09.2020 in response to their bid against Tender ID - 2019\_DTU\_185827\_1 dated 17.12.2019 and the Contract agreement was executed between DTU and M/s Sunil Yadav on 23.09.2020 which came into operation w.e.f. 01.04.2021.

Whereas, as per Clause No. ~ 8 of the Tender document which formed part of the Agreement dated 23.09.2020 it was specifically mentioned that the M/s Sunil Yadav will pay the license fee for the occupation of Central Canteen on quarterly basis, and electricity charges & Water charges will be payable on monthly basis. However, M/s Sunil Yadav has not complied to the same and not deposited the said charges as per tendered rates during the tenure of the said contract.

Whereas, the office letters bearing No. DTU/Gen. Admn./118/2015-16/721-P/236 dated 07.10.2022, DTU/Gen. Admn./118/2015-16/721-P/254 dated 20.10.2022, and DTU/Gen. Admn./118/2015-16/721-P/308/3303 dated 13.12.2023, regarding "non - payment of license fee and other charges of Central Canteen" was served upon M/s Sunil Yadav notifying the arrears.

Whereas, vide office letter bearing No. DTU/ Gen. Admn./118/2015-16/721/P-2/455/4358 dated 29.03.2022, the letter for termination of license was served upon M/s Sunil Yadav with the directions to clear all the dues of license fee and other charges latest by 31.03.2023. Even then M/s Sunil Yadav has not deposited the said charges amounting to Rs. 25,35,705/- (Rupee Twenty Five Lakh Thirty Five Thousand Seven Hundred Five Only) approximately as per available records after adjustment of the Performance Guarantee, Bid Security and Refreshment Bills till date and has committed breach of terms & conditions of the Tender and Agreement.
