**Subject:** Financial Assistance to students belonging to low income group for AY 2025-26.

All desirous and eligible Under Graduate students of DTU, who belongs to lower income group and wish to seek financial assistance for fee concession for academic fee **AY 2025-26** may apply online through the web portal at <http://stest.dtu.ac.in/feeconcession/2025/feeconcession25ug/accounts/login.php>

Portal will be active from **04.09.2025** and the last date for submission of online application is **30.09.2025**.

The students of 2K22 and 2K24 batch who have been given fee waiver benefits for academic session 2024-25 need not apply as they have already been granted fee concession for session 2025-26.

The criteria and guidelines for the fee concession are as under:


### **ELIGIBILITY:**

1. The students whose family income from all known sources is less than Rs. 4,50,000/- per annum will only be eligible to apply for fee concession.
2. The student should not be involved in any in-disciplinary activity (ies) in the University and unfair Means in examination.

### **PROCEDURE:**

1. Login at the web portal only through student email id on <http://stest.dtu.ac.in/feeconcession/2025/feeconcession25ug/accounts/login.php> 04.09.2025 (17.00.00 hrs) onwards.
2. Fill up all details as directed on the site.
3. Submit printed copy of online generated application form along with self-attested copies of required documents in order as specified, duly signed by the student and his/her parent(s)/guardian in academic-UG section window no. 06, DTU
4. No written application for fee concession will be entertained; only online application will be accepted.
5. Site for online application will close on **30.09.2025** (23.59.59 hrs)
6. Last date for submission of hard copy duly completed in all respect is **06.10.2025**. No application will be entertained thereafter.

2. **Income Proof**
  - (a) Income certificate, issued by SDM/1<sup>st</sup> class magistrate.
  - (b) ITR for previous financial year in case of Govt. Employee
3. University fee receipt of the current Academic year 2025-26 for which financial assistance is claimed.
4. Copies of the all mark sheets of previous semesters including 10<sup>th</sup> and 12<sup>th</sup>.
5. First year students have to submit 10<sup>th</sup> and 12<sup>th</sup> class mark sheets and JEE Rank card.
6. Cancelled cheque or Passbook copy of Bank A/c (major account in the name of student only).
7. Electricity bills for the six month (Dec 2024, Jan 2025, Feb 2025, May 2025, June 2025 and July 2025)
8. Property Tax receipts/Home rent receipts/Hostel bills (if applicable)
9. Attach bank statement of all accounts of both parent's and student for last one year.
10. If any fee concession/fee waiver granted:- Attach the proof:-
11. Candidates school fee details paid per month/quarterly: Attach proof (only for private schooling)
12. Students of B. Tech. (Continuing Education) will also attach bank statement of salary A/c for last 6 month.
