

The tenure of the present Vice-Chancellor of Pt. Govind Ballabh Pant University of Agriculture and Technology (GBPUAT), Pantnagar, will conclude on 28th August 2025. Accordingly, it is proposed to appoint a new Vice-Chancellor, and a Search Committee has been constituted to prepare a panel of eminent persons for this purpose.

As the Principal Executive and Academic Officer of the University, the Vice-Chancellor must possess exceptional leadership qualities, administrative experience, and a strong academic background. The incumbent should be a person of integrity, vision, and commitment to steer the University towards academic and institutional excellence.
