### **Agenda 33.1 : Opening Remarks by the Chairperson.**

Vice Chancellor welcomed all the members of the Academic Council in its 33<sup>rd</sup> meeting. He informed that on 20<sup>th</sup> July 2022, two newly constructed Boys and Girls hostels, Dr. A.P.J Aboul Kalam hostel for Boys and Virangana Lakshmi Bai hostel for Girls, have been inaugurated by Hon'ble Deputy Chief Minister of Delhi. These hostels will accommodate an additional 660 girls and 330 boys. The convocation of the University is to be held on 25<sup>th</sup> August 2022 where 2398 UG and 707 PG and around 55 Ph.D degrees will be conferred.

He also informed that the 2021 NIRF rankings placed DTU at the 36<sup>th</sup> position among the Engineering Institutions and at 42<sup>nd</sup> in the category of Universities. This year in NIRF 2022 rankings DTU is placed at the 35<sup>th</sup> position among the Engineering Institutions and at 38<sup>th</sup> in the category of Universities. The University has got 1<sup>st</sup> position as per Times Engineering Ranking 2022. Recently India Today has ranked the University 6<sup>th</sup> amongst the top universities in India, last year the University was ranked 7<sup>th</sup> by India Today in the University Category. The university has been ranked 8<sup>th</sup> amongst Government Engineering Colleges by India Today in 2022.

In 2021-22, 2434 job offers were received by undergraduate and postgraduate students and they were placed in 394 reputed companies. This year highest pay package has gone upto INR 1.84 crores being offered by PALANTIR (London). The highest domestic package has been offered by Apple (INR 64 Lakhs). Further, 137 companies have visited the University for internships and offered internship to 713 students.

***R.12.2 “The candidates of all categories shall normally submit their thesis within a period of four years, from the date of their initial registration in the Ph.D. Programme. However, as a special case, this limit may be extended to maximum up to seven years by the Vice Chancellor on the recommendation of SRC through DRC and Dean-PG after which the registration shall stand cancelled automatically.”***

As per Ordinance for Ph.D. Degree Program: (e) The date of initial registration shall normally be the date on which the DRC recommends the registration of a student for Ph.D. candidacy after successful completion for course work, comprehensive examination and approval of research plan. It will be mandatory for student to register in each semester after obtaining recommendation from DRC based on his performance in the previous semester. This date of his joining the programme will be referred for all intents and purposes. However, in exception cases, the date of registration may be advanced by a maximum of six calendar months by the Academic Council if it is convinced that the student/candidate has spent adequate amount of time on relevant research earlier.

*The Academic Council deliberated on the matter and advised that point based evaluation should be done on regular basis.*

It was submitted here that last candidate upgraded to Civil Engineering branch with JEE Rank 76973 in Delhi-General category and Mr. Arhant tewari belongs to Delhi-General category. Since Mr. Arhant Tewari could not successfully edit his filled choices, there was no change in his branch.

Chairman, JAC observed that based on the rank of Mr. Arhant Tewari, he could have been allotted his 12<sup>th</sup> preference- Civil Engineering.

**Agenda 33.8 : Approval for starting MBA (Executive) - Data Sciences and Analytics in University School of Management & Entrepreneurship (USME).**

It was submitted to the Academic Council that the Board of Studies, USME in its meeting on 10/8/2022 recommended that the Program MBA (Executive) - Data Sciences and Analytics may be launched with an intake of 30 seats initially. This program would cater to the need of industry for mid-career professionals in analytics. This program would also help deepen engagement with industry at various levels.

1. The Admission Eligibility is proposed as follows:

- a. Mathematics/ in Standard XII or Graduation (one paper) with 60% Marks
- b. Graduation with minimum 50% marks on equalities (CGPA) from any recognized University/Institution.
- c. Relevant managerial/professional/technical work experience in industry/organizations of at least three years by the last date of application.

2. The Admission Selection Criterion is proposed as follows:

- a. Merit list for interview will be based on graduation marks. Admission committee will determine the criteria for cut off marks for interview based on graduation.
- b. Selection Criteria for Admission Merit List
  - i. 50 % weightage to academic profile, which will consist of following:
    1. 10% for XII standard marks overall
    2. 10% for X Standard
    3. 30 % for Graduation percentage.
  - ii. 50% weightage to Interview, which would look at criterion such as analytical ability, quality of work experience, fitness for program etc.

3. It was recommended that the program be delivered in flexible mode- where up to 30% of classes will be held in Hybrid mode as per NEP/UGC guidelines and looking at opportunities for overseas collaboration/guest faculty. Students who may need to travel may also attend upto 30% sessions in online mode, with prior permission of the Program Coordinator, as long as that course is being delivered in hybrid mode.
4. The Program would be held on the basis of Quarters, of 11-13 weeks duration as per requirement, and comprise of 84 credits over seven (7) quarters. Each course would be of three credits, where there would be ten hours of in-class interaction per credit and additional hours of self – learning work. This is as per regulatory norms for completing credits and hours of teaching equivalent to four semesters, of more than 20 credits each as per NEP.

The detailed curricular structure was provided in the agenda of the meeting.

It was requested that Academic Council may consider the launch of the MBA (Executive) - Data Sciences and Analytics program as proposed.

### **Supplementary Agenda 33.16 : Establishment of Medical Institute Under DTU.**

It was submitted to the Academic Council that a proposal was submitted to Department Training and Technical Education (DTTE) Govt. of NCT of Delhi to start Medical Institutes in DTU and NSUT. The concept of Medical Institute was proposed in the light of New Education Policy 2020 which encouraged Universities to offer Multi-Disciplinary programs. It is proposed to start MBBS, Dental, Nursing and other related programs at DTU in collaboration with nearby hospitals of Govt. of NCT of Delhi. For this purpose, Bhagwan Mahavir Hospital, Guru Harikishan Marg Pitampura Delhi was identified as the associated hospital for the proposed Medical Institute. The idea was to create a new curriculum in which MBBS, Dental, Nursing students are taught Medical Sciences alongwith allied subjects in the Engineering field and promote inter disciplinary research. IIT, Kharagpur has also launched a Medical Institute on the same lines.

The draft proposal was jointly submitted to DTTE for obtaining approval in principle of the Government of Delhi to start Medical Institutes in DTU and NSUT. The proposal is received back with following observations:

- (i) A Committee to be constituted with inclusion of expert of Medical Sciences/MCI/DCI.
- (ii) The Report of the committee may be placed Before the Board of University.

Accordingly, the Committee was constituted by NSUT as per the order to assess the feasibility and modalities of the Proposal. The Report of the Committee is placed in the Annexure.

The matter was placed before the academic council for its approval in principle so that the proposal can be submitted to BoM DTU.

**Decision : The Academic Council approved the matter in principle and recommended it to the Board of Management for its consideration and approval.**
