

4.	Scale of Pay	Rs. 37400-67000 with Grade Pay of Rs. 10,000/- (6 th CPC), Level-14 with rationalised entry pay of Rs. 1,44,200/- as per 7 th CPC pay matrix.
5.	Whether Selection post or non-selection post	Selection
6.	Age limit	58 years
7.	Educational and other qualifications required for direct recruitment /deputation	Essential 1. Master's degree with at least 55% of the marks or an equivalent grade in a point scale wherever grading system is followed. 2. At least 15 years of experience as Assistant Professor in the Academic Level-11 or AGP of Rs. 7,000/- and above or with 8 years of service in the Academic Level-12 or AGP of Rs. 8,000/- and above including as Associate Professor along with experience in Educational Administration OR Comparable experience in research establishment and/or other institutions of higher education. OR 15 years of administrative experience out of which 08 years shall be as Deputy Registrar or an equivalent post. Note: The Registrar shall hold office for a term of 05 (five) years from the date of which he/she enters his/her office or upto age of 60 years whichever is earlier.
