- In case of failure to complete the job in time, DTU shall impose a penalty of Rs.20,000/- per hour without prejudice and initiate legal action, which the University may deem fit. The Contractor may also be blacklisted for future work. In such situation, DTU shall have the right to make alternative arrangement for completion of the work through some other Contractor of its choice at his/ her/ their risk and cost.
- Caution of the operation, the nature of the ground and working conditions affecting labour and execution of the work. No claim on these issues will be entertained. Any damage to work resulting from weathering conditions, defacing or from any other cause such as negligent act on the part of contractor, shall be made good by the contractor at his own cost.
- The consolidated price quoted shall be firm and final and payable for the goods delivered & installed and shall include all taxes, duties, cartage, labour charges etc. as applicable.
- The quotation which are issued from the office of CPO shall only be accepted, quotations in any other forms shall be summarily rejected without assigning any reasons.
- No T&P and material shall be issued to the firm by the department for installation at site.
