


The Auction will be governed by the following terms/condition.

1. The items will be available for inspection between **11 AM to 4 PM.**
2. The items put up for auction are entirely on "**As is where is**" basis.
3. The successful bidder would be required to make full payment of the bid amount in favour of **Registrar, Delhi Technological University** by demand draft positively before **3PM on 03/10/2017.**
4. After the deposition of entire bid amount and completion of relevant formalities, the successful bidder would also be required to remove all the items put up for disposal latest by **06/10/2017**, before close of normal office hours 5.00 p.m. The office of Estate Officer of DTU would not owe any responsibility thereafter. The penalty @ Rs. 100 per day will be charged thereafter. If the successful bidder does not make the full payment of the bid amount by the prescribed date, it will be blacklisted.
5. **Rs 62,000 (Rupees sixty two thousand only)** is the reserved price of the goods.
