Agenda 46.1 : Opening remarks by the Vice Chancellor.

The Vice Chancellor welcomed Ms. Alice Vaz R., Secretary, Training and Technical Education and Higher Education, Government of NCT of Delhi and all the members along with newly nominated member Professor Nirendra Dev, Civil Engineering Department, DTU in 46th meeting of the Board of Management. He informed that the University has made various achievements in different areas since the last meeting. The Vice Chancellor informed that the University achieved 2nd rank in TIMES Engineering Institute Ranking, 2021 and also secured 7th rank in India Today Ranking, 2021 of Government Colleges. The NIRF India Ranking (Engineering) of DTU is 36 for 2021. The DTU has been placed in the bracket of 601 to 800 by the Time World University Ranking 2022. The DTU has secured 3.5 star rating in Institution's Innovation Council (IIC 3.0) Rating 2020-21. It is a programme of Ministry of Education, Government of India. The IIC encourage, inspire and motivate young students by exposing them new ideas and process resulting in innovative activities in their formative years. More than 1000 Higher Education Institutions have formed IICs in their campuses.

Agenda 46.5 : Approval for introduction of new post graduate programme named "Master of Arts (Economics)" in the University School of Management and Entrepreneurship w.e.f. 2022-23.

It was submitted to the Board of Management that a meeting of the Board of Studies (BoS) of University School of Management & Entrepreneurship (USME) was held on 16th September, 2021 in which it proposed the introduction of a new post graduate programme namely "Master of Arts (Economics)" in the University School of Management and Entrepreneurship w.e.f. 2022-23.

The Academic Council had considered and approved the introduction of new post graduate programme as Master of Arts (Economics) in USME in its 30th meeting held on 22.09.2021.

The Academic Council advised to increase the intake to 60 and also to constitute a committee to re-examine the eligibility criteria for admission to M.A. (Economics) programme. The Council also authorized Vice Chancellor to approve the recommendations of the committee.

Decision: The Board of Management considered and approved the introduction of new post graduate programme as "Master of Arts (Economics)" in USME w.e.f. academic year 2022-23 with an annual intake of 60.

As per the O.M. No.28020/3/20 18-Estt.(C) dated: 11th March, 2019 issued by Government of India, Ministry of Personnel, PG & Pensions Department of Personnel & Training, Confirmation is de-linked from the availability of permanent vacancy in the grade. In other words, an officer who has successfully completed the probation, as prescribed under relevant rules, may be considered for confirmation. Consequent upon the above decision of delinking confirmation from the availability of permanent posts, it emerges that confirmation will be done only once in the service of an officer which will be in the entry grade post/service/cadre provided further confirmation shall be necessary when there is fresh entry subsequently in any other post/service/cadre by way of direct recruitment or otherwise. A specific order of confirmation should be issued when the case is cleared from all angles i.e Vigilance, Work and Conduct Report, Integrity etc.

The Recruitment Rules for the above posts have to be approved by the Board of Management. Accordingly, the Recruitment Rules of these posts have been framed and are placed for approval of Board of Management. Recruitment Rules are an essential requirement for approval of these posts first by the Health Department and afterwards by the Government of NCT of Delhi. In addition, the posts of Radiographer and Lab Technician in Government. of NCT of Delhi are in Level-04 and Level-05 respectively. Accordingly, Board of Management is also requested to approve the above posts in Level-04 and Level-05 so that there is similarity in these posts with that of Government of NCT of Delhi. Agenda 46.9 : Approval of Recruitment Rules of Assistant Director (Physical Education).

It was submitted to the Board of Management that initially at the time of Delhi College of Engineering, one post of Director, Physical Education was sanctioned. Further, in the Recruitment Regulations Notification No. F.2(68)/74-sll dated 21.1.75, the age limit of Director of Physical Education was mentioned as 35 years and the Pay Scale is Rs. 2900-4000 in 4th CPC. The pay scale of Director, physical education was further revised to Rs. 8000-13500 in 5th CPC which is now revised in Level-10 (Entry Pay Rs.57700) as per 7th CPC.

It was pertinent to mention that Sh. Abhay Kumar Srivastava, Director of Physical Education of DTU is superannuated on 30.11.2021 and the post of Director of Physical Education in DTU is lying vacant.

Furthermore, Delhi College of Engineering is upgraded to Delhi Technological University in 2009. The Director of Physical Education is now redesignated as Assistant Director, Physical Education by the UGC and AICTE in Level-10 (Entry Pay Rs.57700) as per 7th CPC.

As per UGC notification, the minimum qualifications for University Assistant Director of Physical Education and Sports / College Director of Physical Education and Sports (may see at page 232/c) are as under: -

(i) A Master's Degree in Physical Education and Sports or Physical Education or Sports Science with 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed)

(iii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET), conducted by the UGC or CSIR, or a similar test accredited by the UGC, like SLET/SET, or who are or have been awarded a Ph.D. Degree in Physical Education or Physical Education and Sports or Sports Science, in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time, as the case may be:



Provided that, candidates registered for the Ph.D. degree prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/ Byelaws/Regulations of the Institutions awarding the degree and such Ph.D. degree holders shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions, subject to the fulfilment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;

The officer had requested for a campus accommodation as per entitlement. The Board of Management had already approved the House Allotment Rules of the University in its 15th meeting held on 08.01.2015. Certain residential accommodations have been earmarked for employees of Delhi Technological University in the said allotment rules. Clause 5 'Essential Services' of the existing House Allotment Rules-2015 is defined as under:-

"Services as given in this section shall be counted as essential services and houses as shown will be earmarked for employees hired against them including those who may be on deputation/contract are temporary hiring:
