Hon'ble Vice Chancellor welcomed all members of the newly constituted Building & works Committee and explained the necessity of additional facilities required at DTU Campus. It was explained that presently the University is run by insufficient infrastructure facilities. Currently the University has over 12,000 students and more than 600 teachers and supporting staff. These minor projects are necessary to meet out the immediate requirement in addition to Stage-1, Phase-II construction at DTU which is in progress and is likely to be completed within two years.
