NOTICE FOR EMPANELMENT

Sub: Appointment as Panel Counsel (Civil) in Delhi Technological University for conducting civil cases in Hon'ble Supreme Court, High Court and Central Administrative Tribunal and District and Subordinate Courts of Delhi.

The Delhi Technological University intends to empanel advocates as Panel Counsel (Civil) for Supreme Court, High Courts, CAT and District and Subordinate Courts of Delhi. Eligible and desirous advocates having required qualification and experience may apply in the prescribed Performa.

Qualification

Bachelor degree in Law from a recognised university and registration with Bar Council Delhi.

Experience required for Supreme Court/High Court & Central Administrative Tribunal

- i) Professional experience of at least 5 years in handling Govt. Department cases (Writ petitions/appeals) in Supreme Court/High Courts and Central Administrative Tribunal (CAT).
- ii) Applicant must possess sound working knowledge on procedures of Supreme Court/High Courts, Central Administrative Tribunal, Services Matters, Labour Court and must have good communication skills and good knowledge of law.

Experience required for District and Subordinate Courts

- i) Professional experience of at least 4 years in the High Courts or District Courts.
- ii) Applicant must possess sound working knowledge on procedures of District Courts, Consumer Forums, Labour Courts and Services Matters and must have good communication skills and good knowledge of law.

Mode of Selection

1. The mode of selection will be interaction by the Selection Committee.
2. In case a large number of applications are received, short-listing of applications may be done. The University reserves the right to decide the criteria of short-listing.
3. Short-listed candidates will then be called for interaction. Intimation will be sent at the email address, as given in the application form or over the mobile number given by the applicant.
4. Candidates will have to produce all original documents at the time of the interview/interaction.
5. Since fee for legal services is payable as notified by Department of Law, Justice & Legislative Affairs, Govt. of NCT of Delhi, all candidates are advised to see the terms and conditions and the fee/remuneration payable to Panel advocates on the website of the Department of Law, Justice & Legislative Affairs, GNCTD.
6. The Delhi Technological University reserves the right to nominate ASG/DSG, Standing Counsel/ASC, or any other advocate, in the panel, or may refer any case/litigation to any other senior counsel.

The University reserves the right to accept or reject any application without assigning any reason. The application submitted will not bind this University to consider him/her for selection for empanelment. The University will be free to draw names from the empanel of advocates of the Govt. of NCT Delhi also.
